Dear Mr. Blanton:

We are in receipt of your request for "a copy of the Gilbane report on the TI/HP building and the estimate detail on the two buildings that were going to cost \$85 million to renovate for classrooms." You also asked for a report on full time teaching PhD's or Doctor of Education and part-time or adjunct instructors that are non-PhD or non-Edd.

The District does not possess a Gilbane report on the TI/HP building. We have identified a total of 59 pages in response to your request for information regarding instructors. Pursuant to §552.271(b) of the Texas Government Code, the District will charge 10 cents per copy for each page. The total estimated charge for your request is \$5.90. Upon receipt of payment the requested documents will be provided to you.

You have 10 business days after the date the District sent this itemized statement to you to respond in writing. Your response should indicate that you accept the estimated charges and request that we proceed with the request, or that you wish to modify your request in response to the itemized statement. You may also notify us that you have sent a complaint to the Attorney General regarding the charges. If the District does not receive a written response from you within 10 business days your request will be considered withdrawn.

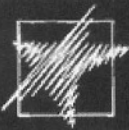
